Urgent Notice cum schedule for WB UG 2021 stray round and college round

In view of Dental Council of India (DCI) letter **DCI/Admission/Admsn/NEETUG/BDS/014/2021/2022/1212** Dated **12.4.2022** received via email id spsrc.mes@gmail.com at **05.40 pm of 12.04.2022**, indicating that last date of server entry of dental admitted candidates remaining unchanged on 11.04.2022, despite several changes and extension of schedule for All India Quota (AIQ) Medical and Dental admission and consequently affecting counseling and admission of State Quota and Management Quota in West Bengal, the candidates who got admission on 12.4.2022 in Dental seats, are hereby allowed for choice up gradation in stray round on humanitarian ground.

For such candidates as stated above, the concerned colleges are hereby instructed to release their deposited fee, bond and original documents on humanitarian grounds with initialization (null and void or roll back) of their admission done on 12.04.2022.

The choices of all the eligible candidates already put up in mop up round for dental vacancies shall not be processed in stray round and the dental vacancies shall not be made available for allotment cum admission in college round until the cut off laid down by DCI is not changed/altered.

The policy of seat conversion followed in mop up round shall also be followed for seat allotment in stray round as well.

For consideration of upgradation of candidates in stray round who were not reported in mop up, their choices above the choice with which they got allotted in mop up, shall be considered only for upgradation. The allotting choice of mop up or the choices below such choice of allotment in mop up shall not be considered for obvious reasons.

The eligible registered candidates who participated in WBMCC UG 2021 counseling and remained not allotted till the stray round, are automatically allowed for college round. They do not need to enroll/pay counseling fee/register again for college round.

The eligible registered candidates, who participated in WBMCC UG 2021 counseling and remained not reported in round 2 and then not paid fee in mop up round, can participate in college round if willing, by payment of counseling fee followed by registration.



The registered candidates, who participated in WBMCC UG 2021 counseling and remained not reported in mop up/stray round, are automatically allowed for college round. They do not need to enroll/pay counseling fee/register again for college round.

However, the eligible registered candidates who clicked re-enrollment button for initialization and failed to enroll, pay fee and register again, have to enroll, pay fee and register afresh for college round if they want to participate.

The eligible candidates who have not enrolled earlier, have to enroll, pay fee and register again for college round. Candidates remaining admitted, surrendered or cancelled candidates are not allowed for stray round or college round.


The fresh schedule for stray round and college round is as follows:-

7	Conduction of college round	<p>28.04.2022</p> <p>The reporting of candidates eligible and desirous of seats shall be with documents in original and requisite college fee from 10 am till 12 noon. After 12 noon reporting time ends and no further candidate allowed. Reported eligible candidates shall be arranged as per rank with attendance and seat allotment as per rank, caste in college as per vacancy.</p> <p>Following allotment they have to be admitted.</p> <p>Both the allotment and admission shall be in NIC server with generation of allotment letter and admission letter.</p> <p>Candidate once getting allotted and admitted cannot change.</p> <p>No authorized representative allowed. Candidate himself/herself has to report physically to any single college of his/her choice having remaining vacancy.</p> <p>The allotment cum admission goes on from 12 noon to 4 pm as per server time</p> <p>After 6 pm the vacancy if any and non admitted candidate list (out of list on 27.04.2022) shall be published. Further extension of college round (if required) shall be notified on 28.04.2022 after 6 pm</p>	1 day
